Privacy Notice – parents, guardians and carers

This privacy notice tells you how we (Newcastle University Student Recruitment Team) handle your personal information. Please read it carefully and contact us if you have any queries.

Why we collect your data

We collect your data to:

- 1. Respond to your enquiry
- 2. Administer yours and your students' involvement in an event or activity
- 3. Evaluate and report on the impact and effectiveness of the event or activity

Our lawful basis for processing enquiries is our legitimate interests in providing information about the University to parents of prospective and current students. If you do not provide us with a means of contacting you we will be unable to respond to your enquiry, and so the processing is necessary for us to meet that interest.

If you and/or your child/ward attend an on campus event, we will ask for some data that is considered as special category data by data protection law. We ask for some health information as we are required under the Equality Act 2010 to ensure that we make any reasonable adjustments for you/your child/ward to be able to fully participate in our on campus events.

We believe that the work we carry out to promote wider engagement and participation in higher education is carried out in the public interest. We need to ensure that the money we receive from government funding agencies is spent appropriately and has a positive impact. In order to measure impact and to conduct our activities, we need to collect your data.

What we will use your data for

Your data will be used for contact with you to answer your enquiry, administer yours and your child's/ward's participation in the relevant event or activity, reporting, research, and monitoring and evaluation purposes as described below.

How we store your data

We will take all appropriate technical and organisational measures to keep your data secure. All data will be stored in accordance with data protection laws and other applicable legislation. We will retain your data for one full academic year. After this time anonymised data will be archived and retained for research, monitoring and evaluation purposes.

If you withdraw from any of the activities or events provided by Newcastle University Student Recruitment Team, your data will be held for tracking purposes unless you specifically inform us that you do not want your data to be used. Who we share your data with

In order to successfully administer your participation in the on campus event, we will share your data, if necessary, with the relevant services at Newcastle University.

Sharing your data to evaluate and report on the impact of our events will not affect you individually. For all reporting purposes or Freedom of Information requests, your data will be aggregated or made anonymous. You will not be individually identified in any reports and confidentiality will be maintained at all times.

Your rights

You have the right to request that your data is removed from our system. Please contact the Student Recruitment Team if you wish to do this or if you have a query or complaint about the use of data. You can telephone 0191 208 6094 or email outreach@ncl.ac.uk.

Please note, if would like to attend one of our events on campus you will need to provide us with some data in order for us to administer your involvement. You can, however, request that we do not share your data with any parties listed other than Newcastle University.

Under data protection law you are entitled to request copies of all the personal data that the Student Recruitment Team at Newcastle University holds about you.
